



TERMS OF BUSINESS

N.B. The terms quoted below are the excerpt of the original German version of our terms of business and are meant only for foreign customers i.e. non-Austrian residents.

Method of Payment

A deposit of 1/3 of the fee as prescribed is required promptly following the notification of acceptance onto the course.

The remainder of the fee must be in our account at least six weeks prior to the course commencing.

By default, we reserve the right to charge an additional EUR 40,- fee plus interest on late payments which will be added to your invoice.

Cancellation Insurance

A successful registration can only be withdrawn by means of a registered letter, received at least six weeks prior to the course commencing. In this instance, EUR 60,- will be retained for administration costs.

If you wish to cancel later than six weeks before the course, your child does not take part in paid for activities, or departs prematurely from the camp, no refund or credit can be offered. All remaining monies due will be immediately paid.

→ It is the right of every person taking part in the course who may cancel, to find someone to take their place. In this case, a written notification is required from both parties.

Liability

The liability of the organizer for damage that any course participant may cause is to compensate. Damage caused by a third party is non-applicable.

"ENGLISH FOR KIDS" is not responsible for spoiling, disturbance or damages in connection with the running of the camp.

→ English For Kids will not be held responsible for the loss of private property, such as mobile phones, valuable things and pocket money.

→ If the specific instructions of the course direction and its personnel are not adhered to, liability on our side will not be accepted.

Parents are liable for costs resulting from damages their child may cause.

→ Every effort has been made to guarantee that information in our brochures and on our web site is kept current. However, changes may be necessary and therefore, the content of the prospectuses should not be read as entirely detailed or in any way a contract between parent and institute.

→ We strive to accommodate your children in the occupancy desired by you, but a claim may not be raised if this proves impossible.

IMPORTANT INFORMATION

Supervision and Care

Parents are advised that the children will have free time (break times after meals) and after the daily programme. During these times there is no strict supervision except for the „Day Camp Vienna Primary“.

→ No liability can be accepted for course participants who leave the camp premises of their own accord.

The Price Includes:

Accommodation in rooms of 5 beds, with each room having an entrance area and private bathroom with shower and WC.

Full board is included with drinks at all meal times.

Course fees are based on at least 24 study sessions per week each lasting at least 45 minutes. Lessons include the use of Internet and PC equipment, project and reference materials; afternoon programmes include free use of the "ENGLISH FOR KIDS" video room, sports equipment and sports areas; transfers to off site venue; entrance fees, and taxes.

The Price Does Not Include:

Anything outside of the e4kids programme, especially in the free evenings, the coin operated internet machines, arcade games such as pinball and pool/billiards tables, optional opportunities to participate in extra sports, transport to and from the camp premises; cancellation and accident insurance.

Optional Sports

Horse riding, Climbing wall

These activities are offered on days planned by us and all are completely optional. These activities will be led by a trained instructor and, where possible, an English speaking teacher.

→ Riding and climbing involve risk and extra cost. For your child to take part in any of these sports, please mark the registration form. This is binding and payment should be made upon arrival at the camp.

→ In the cited prices, the transfer is included. A later registration is possible if places are still available. Costs are determined by each organizer provided and which may be subject to change.

→ "ENGLISH FOR KIDS" accepts no responsibility or liability in the event of any accidents that may occur from any of these sports, especially riding accidents. Students wishing to ride outside of the indoor practice area may only do so with a certain level of riding proficiency and parental consent.
